Representatives of the OWNER and the ENGINEER will be present to discuss the Project. Bidders are required to attend and participate in the conference. ENGINEER will transmit to all prospective Bidders of record such Addenda, as ENGINEER considers necessary in response to questions arising at the conference. Oral statements may not be relied upon and will not be binding or legally effective.

Bidder must provide a certified check payable to the Erie Water Works or a Bid Bond on the Bid Form executed by the BIDDER and a surety company approved by the EWW, in an amount equal to ten percent (10%) of the total amount of the Bid, must be submitted with each Bid or Bids will be considered nonresponsive and immediately rejected.

No bid may be withdrawn for sixty (60) calendar days after the scheduled closing time for receipt of bids.

The Contractor must insure that employees and applicants for employment are not discriminated against because of their race, creed, color or national origin.

Prior to contract award, Contractor must submit an E-Verify Program Verification in compliance with the Public Works Employment Verification Act 127 of 2012.

EWV reserves the right to reject any or all bids or parts thereof or to waive any informalities in the bidding.

Bidder shall be required to submit insurance certificate, performance bonds, labor and material bonds as outlined in the specifications.
