No bid bond shall be waived or returned because the Bidder has failed to or cannot comply with any requirement as set forth in the plans, specifications or any applicable statutes of the Commonwealth of Pennsylvania or any applicable ordinances. No bid may be withdrawn for (60) days after the scheduled closing time for receipt of bids.
