Project consists of structural demolition, site clearance, asbestos abatement and related activities required for demolition of one commercial building in complete compliance with all Federal, State and Local regulations.**

A non-mandatory Pre-Bid conference will be held at 11:00 AM on Tuesday, November 15, 2016 at the Lincoln School Building located at 4330 Liberty Way, Elizabeth, PA.

The Pennsylvania Prevailing Wage Act applies to this project. Proposals to receive consideration must be accompanied by a Certified Check or Bidder’s Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of Forward Township/Steel Rivers Council of Governments in an amount equal to ten percent (10%) of the Proposal as a guarantee that, if the Proposal is accepted, the successful Bidder will immediately enter into Agreement after the Notice of Award of the Contract and commence start of construction immediately thereafter. Each Proposal shall be delivered in a sealed envelope clearly marked on the outside with the words “Bid for Demolition of Lincoln School, Lincoln Borough”.

“Compliance is required with the Pennsylvania Prevailing Wage Act of 1961, P.L. 987, No. 442; Title VI and other applicable provisions of the Civil Rights Act of 1964; the Department of Labor Equal Opportunity Clause (41 CFR 60-1.4); Executive Order 11625 (Utilization of Minority Business Enterprise); Executive Order 12138 (Utilization of Female Business Enterprise); in compliance with Section 504 of Rehabilitation Act of 1973 and Americans with Disabilities Act of 1990; the Allegheny County MBE/WBE Program enacted July, 1981, which sets forth goals of 13 percent Minority and 2 percent Female Business Enterprise; and the Allegheny County Ordinance #6867-12, setting forth goals of 5 percent Veteran-Owned Small Businesses.”

The Steel Rivers Council of Governments reserves the right to waive any informalities or to reject any or all proposals, or any part thereof. No Bidder may reject his/her bid for the period as specified in the project bid documents after the scheduled closing time for receipt of bids.
