Millers Run Interceptor Sewer Improvements**

A Mandatory Pre-Bid Conference will be held at 10:00 AM local time on Wednesday, January 31, 2018, at the Municipal Authority of the Township of South Fayette office, 900 Presto Sygan Road, Bridgeville, PA 15027.

Work under this Contract covers the furnishing of all labor, material, plant, utilities and services required for the construction of approximately 8,750 lineal feet of 8-inch through 24-inch gravity interceptor sewers along with demolition and abandonment of certain existing sanitary sewers and appurtenances. The Project is located within South Fayette Township, Allegheny County, Pennsylvania.

No bid may be withdrawn for a period of sixty (60) days after the time of the opening of the bids.

Bidders shall submit, with their bids, an E-Verify Program

Verification in compliance with the Public Works Employment Verification Act 127 of 2012.

A certified bond payable to the Municipal Authority of the Township of South Fayette or a bid bond on the bid form executed by the Bidder and a surety company approved by the OWNER, in an amount equal to ten percent (10%) of the total amount of bid, must be submitted with each bid or bids will be considered non-responsive and immediately rejected. No bid bond shall be waived or returned because the Bidder has failed to or cannot comply with any requirements as set forth in the Plans, Specifications or any applicable statues of the Commonwealth of Pennsylvania or any applicable ordinances.

Bidders must insure that employees and applicants for employment are not discriminated against because of race, color, religion, sex or national origin.

Bidders shall be required to submit insurance certificate, performance bonds, labor and material bond as outlined in the proposal.

The Municipal Authority of the Township of South Fayette reserves the right to reject any or all bids or to waive any informalities in the bidding process.
