**All bidders must be PennDOT pre-qualified as a prime contractor and must also meet the necessary work classification codes for the completion of the project. All bids submitted must have the contractor's valid pre-qualification certification attached or it will be rejected.**

A certified bank check or bond payable to North Huntingdon Township or a bid bond on the bid form executed by the Bidder and a surety company approved by the OWNER, in an amount equal to ten percent (10%) of the total amount of bid, must be submitted with each bid or bids will be considered nonresponsive and immediately rejected. No bid bond shall be waived or returned because the Bidder has failed to or cannot comply with any requirements as set forth in the plans, specifications or any applicable statutes of the Commonwealth of Pennsylvania or any applicable ordinances. No bid may be withdrawn for (60) sixty days after the scheduled closing time for receipt of bids.

Contractor shall submit an E-Verify Program Verification in compliance with the Public Works Employment Verification Act 127 of 2012.

Bidder must insure that employees and applicants for employment are not discriminated against because of race, color, religion, sex or nation origin.

North Huntingdon Township reserves the right to reject any or all bids or to waive any informalities in the bidding.
