A certified check, bank draft or a Bid Bond executed on the prescribed form by the Bidder and a Surety Company, in the amount equal to ten percent (10%) of the Bid, shall be submitted with each Bid to guarantee the Bidder's entrance into this Contract if given the award. No Bid Bond shall be waived or returned because the Bidder failed to or cannot comply with any requirements set forth in the Bidding Documents or any applicable statutes of the United States, the Commonwealth of Pennsylvania and/or all local ordinances.

No Bid may be withdrawn for a period of one hundred twenty (120) days after the time of the opening of the bids.

The Contractor must insure that employees and applicants for employment are not discriminated against because of their race, creed, color or national origin.

Contractor shall submit an E-Verify Program Verification in compliance with the Public Works Employment Verification Act 127 of 2012.

Attention is called to the fact that funding is being provided by the Pennsylvania Department of Community and Economic Development (DCEd) pursuant to the Washington County's Local Share Account (LSA) Program. The Program requirements, as outlined in the specifications, are to be adhered to, that not less than the minimum salaries and wages, as established by the Pennsylvania Department of Labor, must be paid on this project and the CONTRACTOR must ensure that employees and applicants for employment are not discriminated against because of their race, creed, color, sex or national origin. Materials utilized in this project must comply with the provisions of the Steel Procurement Act.
