REQUEST FOR PROPOSALS

Notice is hereby given that sealed proposals will be received by the Steel Rivers Council of Governments office located on the first floor of the Steel Valley Human Service Center, Room 100, 1705 Maple Street, Homestead PA 15120. Bid proposals will be received until 10:00 A.M. prevailing time on May 26, 2017 whereupon bids will be opened and read immediately thereafter for the following project:

CD 42-7.6 Pedestrian Step Repairs, Glassport Borough: The project consists of the 4th Street and 9th Street Step Repair. 4th Street will consist of the demolition and replacement of 13 cast-in-place concrete stairs. Work will also include crack repair, joint sealing, spall repair, and wall repair. Stairs will be replaced in kind. 9th Street will consist of the construction of new composite and pressure treated wood stairs over top of the existing concrete stairs.

Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of the Steel Rivers Council of Governments and/or Municipality in an amount equal to ten percent (10%) of the Proposal as a guarantee that, if the Proposal is accepted, the successful Bidder will immediately enter into Agreement after the Notice of Award of the Contract and commence start of construction immediately thereafter. Each proposal shall be delivered in a sealed envelope clearly marked on the outside with the words "Bid for Pedestrian Step Repairs, Glassport Borough."

Predetermined wage rates as established by the U.S. Department of Labor apply. "Compliance is required with the Davis-Bacon Act and other Federal Labor Standard Provisions; Title VI and other applicable provisions of the Civil Rights Act of 1964; the Department of Labor Equal Opportunity Clause (41 CFR 60-1.4); Section 109 of the Housing and Community Development Act of 1974; Executive Order 11625 (Utilization of Minority Business Enterprise); Executive Order 12138 (Utilization of Female Business Enterprise); in compliance with Section 504 of Rehabilitation Act of 1973 and Americans with Disabilities Act of 1990; the Allegheny County MBE/WBE Program enacted July, 1981, which sets forth goals of 13 percent Minority and 2 percent Female Business Enterprise; and the Allegheny County Ordinance #6867-12, setting forth goals of 5 percent Veteran-Owned Small Businesses. Further, notice is hereby given that this is a Section 3 Project under the Housing and Urban Development Act of 1968 (as amended), and must to the greatest extent feasible, utilize lower income residents for employment and training opportunities and Section 3 Business concerns and all contracts and subcontracts for this project shall contain the "Section 3 Clause" as set forth in 24 CFR, Part 135.38. Moreover, compliance is required by the prime contractor and all subcontractors with the document entitled federal General County Conditions that is included with the bid materials furnished, these federal General County Conditions to be incorporated by reference into all construction contracts between operating agency and contractor, contractor and subcontractor(s), and subcontractor(s) and lower tiered subcontractor(s)."

The Steel Rivers Council of Governments reserves the right to waive any informalities or to reject any or all proposals, or any part thereof. No Bidder may reject his/her bid for the period as specified in the project bid documents after the scheduled closing time for receipt of bids.
