Bid Proposals will be received until 10:00 A.M. prevailing time on May 26, 2016 whereupon bids will be opened and read immediately thereafter for the following projects:

Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of the Steel Rivers Council of Governments and/or Municipality in an amount equal to ten percent (10%) of the Proposal. Each Bid shall be enclosed in a sealed envelope bearing the name and address of the bidder on the outside, addressed to the Steel Rivers COG and marked with the project name.
