Public notice is hereby given that the Clairton Municipal Authority will receive sealed bids at the Authority Office, 1 North State Street, Clairton, PA 15025, until 10:00 AM prevailing time, Monday, November 18th, 2019, in City of Clairton under the following contract.

**Contract No. 2019-03 - DRY RUN
INTERCEPTOR SEWER IMPROVEMENTS PHASE 1**

Sanitary Sewer work under this Contract covers the furnishing of all labor, material, plant, utilities and services required for the construction of gravity sewer along with demolition and abandonment of certain existing sanitary sewers and appurtenances. The project is located within the City of Clairton. Contract No. 2019-03, Dry Run Sanitary Sewer Improvements Phase 1, consists of construction of approximately 760 lineal feet of 30 inch PVC interceptor sewer and a new CSO Chamber. Work shall also include the demolition and modification of sanitary manholes and abandonment of existing interceptor sewer. All demolition work shall not take place until after all new sewers have been properly tested and put into operation as per these specifications.

Equipment and Services to be provided shall be according to the specifications which are on file at the office of KLH ENGINEERS, INC., 5173 Campbells Run Road, Pittsburgh, Pennsylvania, 15205, and at the Municipal Authority Office.

Contractor shall submit an E-Verify Program Verification in compliance with the Public Works Employment Verification Act 127 of 2012.

A certified bond payable to the Clairton Municipal Authority or a bid bond on the bid form executed by the Bidder and a surety company approved by the OWNER, in an amount equal to ten percent (10%) of the total amount of bid, must be submitted with each bid or bids will be considered non-responsive and immediately rejected. No bid bond shall be waived or returned because the Bidder has failed to or cannot comply with any requirements as set forth in the plans, specifications or any applicable statutes of the Commonwealth of Pennsylvania or any applicable ordinances.

SUCCESSFUL BIDDING BIDDER awarded this contract shall provide a performance surety in the amount of one hundred percent (100%) of the Contract amount.
