A certified check payable to the Clairton Municipal Authority or a bid bond on the bid form executed by the Bidder and a surety company approved by the Owner, in an amount equal to ten percent (10%) of the bid, shall be submitted with each bid, to guarantee the Bidder's entrance into a contract if given the award. No bid bond shall be waived or returned because the Bidder has failed to or cannot comply with any requirements as set forth in the plans, specifications, or any applicable statutes of the Commonwealth of Pennsylvania or any applicable municipal ordinances. No bid may be withdrawn for one hundred twenty (120) calendar days after the scheduled closing time for receipt of bids.

Contractor shall submit an E-Verify Program Verification in compliance with the Public Works Employment Verification Act 127 of 2012.

BIDDER'S SURETY -- A certified check payable to the Clairton Municipal Authority or a bid bond on the bid form executed by the Bidder and a surety company approved by the OWNER, in an amount equal to ten percent (10%) of the total amount of bid, must be submitted with each bid or bids will be considered nonresponsive and immediately rejected.

Attention is called to the fact that PENNVEST financing is being provided for this project through federal funds provided by EPA financial assistance dollars. Therefore, all contractors are required to pay not less than the minimum salaries and wages in compliance with Davis-Bacon and any other associated federal requirements. The CONTRACTOR shall ensure that employees and applicants for employment are not discriminated against because of their race, creed, color or national origin.

SUCCESSFUL BIDDER awarded this contract shall provide a performance surety in the amount of one hundred percent (100%) of the Contract amount.
