All bidders must be PennDOT pre-qualified as a prime contractor and must also meet the necessary work classification codes for the completion of the project. All bids submitted must have the contractor's valid pre-qualification certification attached or it will be rejected.

No Bid may be withdrawn for a period of sixty (60) days after the time of the opening of the bids.

Contractor shall submit an E-Verify Program Verification in compliance with the Public Works Employment Verification Act 127 of 2012.

BIDDER'S SURETY -- A certified check payable to Stowe Township or a bid bond on the bid form executed by the Bidder and a surety company approved by the OWNER, in an amount equal to ten percent (10%) of the total amount of bid, must be submitted with each bid or bids will be considered nonresponsive and immediately rejected. No bid bond shall be waived or returned because the Bidder has failed to or cannot comply with any requirements as set forth in the plans, specifications or any applicable statutes of the Commonwealth of Pennsylvania or any applicable ordinances.
