A Pre-Bid conference will be held at 1:00 PM, Wednesday, June 5, 2024, at the office of the City of St. Marys, 11 LaFayette Street, St. Marys, PA 15857. Representatives of Owner and Engineer will be present to discuss the project. Bidders are required to attend and participate in the conference. Engineer will transmit to all prospective Bidders of record such Addenda, as Engineer considers necessary in response to questions arising at the conference. Oral statements may not be relied upon and will not be binding or legally effective.

No Bid may be withdrawn for a period of sixty (60) days after the time of the opening of the bids.

Contractor shall submit an E-Verify Program Verification in compliance with the Public Works Employment Verification Act 127 of

2012.

BIDDER'S SURETY -- A certified check payable to the City of St. Marys or a bid bond on the bid form executed by the Bidder and a surety company approved by the OWNER, in an amount equal to ten percent (10%) of the total amount of bid, must be submitted with each bid or bids will be considered nonresponsive and immediately rejected.

SUCCESSFUL BIDDING BIDDER awarded this contract shall provide a performance surety in the amount of one hundred percent (100%) of the Contract amount.
