Sealed bids for the construction of the Project will be received at Somerset Township office located at 615 Vanceville Road, Eighty Four, PA until Wednesday, July 2, 2025, at 2:00 P.M. local time. At that time the Bids received will be publicly opened and read.

“Pre-bid Conference” A mandatory pre-bid conference for the Project will be held at 9:00 A.M. on Wednesday, June 25, 2025, at the project site located at 25 Spud Drive, Scenery Hill, PA 15360. Bidders that attended the previous pre-bid conference are not required to attend this one. Bids will not be accepted from Bidders that do not attend the mandatory pre-bid conference.

The Somerset Board of Supervisors will action taken on the bids at a regular meeting of the Somerset Township Board of Supervisors on July 9, 2025 at 6:00 P.M. in the Somerset Township Municipal Building 615 Vanceville Road Eighty Four, PA 15330.

The successful bidder will be required to post a performance bond in an amount of at least 10% of the amount of the bid.

The Project has an expected duration of 180 days.

Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including addenda, if any, obtained from sources other than the Issuing Office.

Bidding Documents may be purchased from the Issuing Office during the hours indicated above for \$105.00. Cost does not include shipping charges. Upon Issuing Office's receipt of payment, printed Bidding Documents or electronic documents on compact disk will be sent via the prospective Bidder's delivery service. The shipping charge amount will depend on the shipping method chosen.

**Instructions to Bidders.**

For all further requirements regarding bid submittal, qualifications, procedures, and contract award, refer to the Instructions to Bidders that are included in the Bidding Documents.

Attention is called to the fact that prevailing minimum wage rates as determined by the Secretary of the Department of Labor and Industry must be paid by the Contractors on this project and that employees and applicants for employment shall not be discriminated against because of their race, age, color, religion, sex, national origin, or handicap. Each contractor is required to meet the requirements of Public Works Employment Verification Act, Act 127 of 2012.

Any and all steel products used or supplied in the performance of the contract or any subcontracts shall be from steel made in the United States.

The Owner hereby reserves the right, which is understood and agreed to by all bidders, to refuse and reject any or all bids submitted, and also reserves the right to waive any informality in bids received.

Except as otherwise provided by law, no bidder may withdraw its bid for sixty (60) days after the Bid Due Date, unless the contract award is delayed by a required approval of another government agency, the sale of bonds, or the award of a grant or grants, in which case the Bids shall remain open to acceptance and shall be irrevocable for a period of sixty (60) after the Bid Due Date.
