CONTRACT NO. 2025-01 WASTEWATER TREATMENT PLANT ACCESS BRIDGE REPLACEMENT

BID OPENING - Sealed bids shall be submitted online via the PennBid Program until 11:00 AM local time Tuesday, August 12, 2025, at which time all bids will become publicly available.

A Pre-Bid conference will be held at 1:00 PM, Wednesday, July 30, 2025, at the St. Marys Wastewater Treatment Plant, 282 State Street, St. Marys, PA 15857. Representatives of OWNER and ENGINEER will be present to discuss the Project. Attendance at the Pre-Bid Conference is encouraged but not required. Bidders are encouraged to attend and participate in the Pre-Bid Conference. ENGINEER will transmit to all prospective Bidders of record such Addenda as ENGINEER considers necessary in response to questions arising at the Conference. Oral statements may not be relied upon and will not be binding or legally effective.

No Bid may be withdrawn for a period of sixty (60) days after the time of the opening of the bids.

Contractor shall submit an E-Verify Program Verification in compliance with the Public Works Employment Verification Act 127 of 2012.

BIDDER'S SURETY -- A certified check payable to the City of St. Marys or a bid bond on the bid form executed by the Bidder and a surety company approved by the OWNER, in an amount equal to ten percent (10%) of the total amount of bid, must be submitted with each bid or bids will be considered nonresponsive and immediately rejected.

SUCCESSFUL BIDDING BIDDER awarded this contract shall provide a

performance surety in the amount of one hundred percent (100%) of the Contract amount.
