ENGINEER will transmit to all prospective Bidders of record such Addenda, as ENGINEER considers necessary in response to questions arising from the meeting. Oral statements may not be relied upon and will not be binding or legally effective.

No Bid may be withdrawn for a period of one hundred twenty (120) days after the time of the opening of the bids.

Prior to contract award, contractor shall submit an E-Verify Program Verification in compliance with the Public Works Employment Verification Act 127 of 2012.

BIDDER'S SURETY -- A certified check payable to the Erie Water Works or a bid bond on the bid form executed by the Bidder and a surety company approved by the OWNER, in an amount equal to ten percent (10%) of the total amount of bid, must be submitted with each bid or bids will be considered nonresponsive and immediately rejected.

SUCCESSFUL BIDDING BIDDER awarded this contract shall provide a performance surety in the amount of one hundred percent (100%) of the Contract amount.

EQUAL OPPORTUNITY EMPLOYER -- Erie Water Works fully complies with the provisions of this act. All qualified bidders are invited to submit a proposal.

Erie Water Works has established a 10% minority participation goal for all Prime Contractors bidding on the project, and any associated subcontractors hired by the prime contractors in order to complete the project. The goal relates to all construction related employees/trades to be employed on the project. Prime Contractors are required to provide a quarterly summary of minority participation in a format agreed to by ERIE WATER WORKS after the construction contracts are executed.

Federally Funded Projects
