A mandatory Pre-Bid meeting will be held at the West Mifflin Sanitary Sewer and Stormwater Authority Belmont Pump Station, located at 151 Belmont Avenue, West Mifflin, PA 15122 on Friday, January 9th, 2026, at 9:00 A.M. to review the details of project requirements. Attendance at this meeting is mandatory.

Contractor shall submit an E-Verify Program Verification in compliance with the Public Works Employment Verification Act 127 of 2012.

BIDDER'S SURETY -- A certified check payable to the WEST MIFFLIN SANITARY SEWER & STORMWATER AUTHORITY or a bid bond on the bid form executed by the Bidder and a surety company approved by the OWNER, in an amount equal to ten percent (10%) of the total amount of bid, must be submitted with each bid or bids will be considered nonresponsive and immediately rejected.
