Anaerobic Digester Improvements Project

Sealed bids for the construction of the Project will be received electronically via the PennBid Program by the Washington East-Washington Joint Authority until Tuesday, August 18, 2026, at 10:00 A.M. local time.

The Project includes the following Work: the construction of a Digester Building Addition, Installation of Digester heating and mixing equipment, and supplemental systems to support the new equipment at the Washington-East Washington Joint Authority (WEWJA) Wastewater Treatment Plant in South Strabane Township, Washington County, PA.

The Project has an expected duration of four hundred fifty (450) days.

Instructions to Bidders.

For all further requirements regarding bid submittal, qualifications, procedures, and contract award, refer to the Instructions to Bidders that are included in the Bidding Documents.

Attention is called to the fact that prevailing minimum wage rates as determined by the Secretary of the Department of Labor and Industry must be paid by the Contractors on this project and that employees and applicants for employment shall not be discriminated against because of their race, age, color, religion, sex, national origin, or handicap. Each contractor is required to meet the requirements of Public Works Employment Verification Act, Act 127 of 2012.

Any and all steel products used or supplied in the performance of the contract or any subcontracts shall be from steel made in the United States.

The Owner hereby reserves the right, which is understood and agreed to by all bidders, to refuse and reject any or all bids submitted, and also reserves the right to waive any informality in bids received.

Except as otherwise provided by law, no bidder may withdraw its bid for ninety (90) days after the Bid Due Date, unless the contract award is delayed by a required approval of another government agency, the sale of bonds, or the award of a grant or grants, in which case the Bids shall remain open to acceptance and shall be irrevocable for a period of ninety (90) days after the Bid Due Date.
